ICAI MSME and Startup Yatra 2024

ICAI MSME & Startup Yatra 2024, a sequel to the previous yatra recorded in the Asia Books of Records was a grand success of the Committee. The yatra was inaugurated on 27th June 2024 by CA. Ranjeet Kumar Agarwal, President, ICAI and CA Aman Gupta, cofounder and CMO at boat Lifestyle. It was flagged off from KTPO, Bengaluru, on 29th June 2024 and concluded on 19th October 2024 during the Finale Event



held at Terapanth Bhawan, Mumbai. This road journey covered more than 21,000 km, traversing multiple states, with the aim of raising awareness about various Central and State Government schemes and opportunities for MSMEs and Startups. Similar to the MSME Yatra 2022, this campaign promoted government schemes for MSMEs and Startups, under the theme "Financial & Tax Literacy" as part of the "Hamara Sankalp Viksit Bharat" initiative of the Institute of Chartered Accountants of India (ICAI). Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE)

The Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE), established by the Government of India, aims to facilitate credit access for micro and small enterprises (MSEs) by providing credit guarantees on loans from financial institutions. This initiative, developed by the Ministry of MSME and SIDBI, supports entrepreneurship by offering collateralfree loans and mitigating lending risks. The scheme covers term loans and working capital up to 5 crore (effective from April 2023), with a guarantee of 75-85%, offering higher coverage for micro-enterprises and women entrepreneurs. Eligible MSEs in manufacturing and services can benefit from this scheme, which provides a guarantee for up to 5 years or the loan term.

For MSEs, CGTMSE ensures easier access to credit at lower interest rates, while lenders benefit from reduced risk and greater confidence in lending to the sector. Chartered Accountants (CAs) can play a crucial role by assisting MSEs in loan structuring, risk assessment, compliance, and financial planning, thereby helping both MSEs and lenders leverage the full benefits of the scheme.
